- 5. Liaison officer Ana Medina was not able to attend the meeting but did provide her report as follows:
  - ➤ Ms. Medina continues to make monthly visits to the Brownsville County Tax Office which are scheduled on the 1<sup>st</sup> and 3<sup>rd</sup> Wednesday of the month from 8:30 a.m. to 12:00 p.m. Her last visit was on December 1<sup>st</sup> and her next scheduled visit is December 15<sup>th</sup>.
  - Ms. Medina had the opportunity to attend an Exemptions Seminar in Austin, Texas. She indicated it was a great opportunity to converse with other counties in the state and review how they address exemption applications.

The Board determined that it is not a grievable item for the Board and that they do not have any jurisdiction over the matter.

The District nor the Board have the authority to change the process. Any changes to the process would have to be through legislation.

David Argabright motioned to accept the board's decision that they do not have any jurisdiction over this matter. Seconded by Jesse Villarreal.

Dr. Prisci Roca Tipton abstained from any discussion or motion made on this item.
